

From the Desk of Jeff Kittle: Instructional Days



The winter of 2009-2010 has seen a resurgence of winter weather reminiscent of the 1970's when the mercury would plummet into the single digits, the snow would pile up, and you would not see the sun for weeks. Severe winter weather also brings with it hazardous road conditions which, in turn, can cause school to be canceled. Through January 8th, Barbour County Schools has lost seven instructional days. In our school calendar, four Out-of-School (OS) days are scheduled for June 3rd and 4th and also June 7th and 8th. These OS days will be rescheduled as instructional days to help compensate for the loss of instructional days due to the inclement weather.

Schools were closed on December 21st and 22nd due to inclement weather. During this timeframe, Governor Manchin declared a "State of Emergency" for the state. This situation has prompted some to ask, "If the county schools are closed because of inclement weather and the Governor declares a state of emergency, must a county school system make up the lost instructional days?" State Superintendent, Dr. Steven Paine, recently issued a memorandum to all county superintendents on this very subject. In his memo, Dr. Paine states that indeed school systems are to reschedule days in their calendars later in the year to make up missed instructional days that occurred earlier due to inclement weather.

Finally, several school calendar changes have been made by consensus due to the weather-related loss of instructional time: A) the second nine-weeks and first semester will end on January 25; B) the third nine-weeks will commence on January 26; C) report card distribution will occur on February 1; D) elementary parent-teacher conferences will now be held on February 2nd and middle school parent-teacher conferences have been rescheduled for February 4th..

Kasson Honored as WV Exemplary School for Fifth Time

For the fifth consecutive year, Kasson Elementary/Middle School has been named a West Virginia Exemplary School by the state Office of Education Performance Audits. KEMS represents the top 10 percent of elementary/middle schools in the state of West Virginia.

West Virginia's 2009 Exemplary Schools were honored during a celebration on November 9 at the Embassy Suites conference center in Charleston.

To achieve exemplary status, a school must meet a high level of student proficiency in core subjects on the WESTEST II; meet a student attendance rate at or above 94 percent; meet a student graduation rate at or above 85 percent; meet a college or post-secondary attendance rate of 55 percent; and meet a 5 percent standard of students who successfully complete Advanced Placement, dual credit and honors classes as defined by state Policy 2510. Approximately 8 to 10 percent of West Virginia schools qualify for the honor annually.

Kasson Elementary/Middle School, located in the northeastern corner of Barbour County, is the educational home to some 187 students in grades pre-kindergarten through eight. "I am proud of the students, faculty and staff members for their hard work and dedication," KEMS Principal Michelle Barb. "It takes support from the school, parents and the community to achieve this top honor."

Barbour County Superintendent of Schools Dr. Deede Lundeen added, "Once again, Kasson School shines like a beacon in Barbour County. For the fifth year in a row, the students, faculty, administration and community have come together to produce an exemplary school. The Board of Education and I are very proud. Well done."

21st Century Lesson



According to a radio report, a middle school in Oregon was faced with a unique problem. A number of girls were beginning to use lipstick and would put it on in the bathroom. That was fine, but after they put on their lipstick they would press their lips to the mirrors, leaving dozens of little lip prints.

Finally the principal decided that something had to be done. She called the girls into the bathroom and met them there with the janitor, Mr. Jackson. She explained that all these kiss marks were causing a major problem for the custodian, who had to clean the mirrors every night. To demonstrate how difficult it was to clean the mirrors, she asked Mr. Jackson to scrub one of them. He took out a long-handled squeegee, dipped and swirled it in the nearest toilet and then cleaned one of the mirrors. Magically, since then, there have been no lip prints on the mirrors.

ParentLink System Improves Communication Between Schools and Homes

Like most organizations, Barbour County Schools is constantly looking for ways to improve and standardize communication, both within the system and with parents and other stakeholders. One such notable effort is the addition of the new ParentLink service, a national product that is gaining in popularity across the nation..

ParentLink became fully operational in the district during the fall of 2009 as part of a collaborative effort with interested parties in RESA VII, which made the service more affordable for the participating counties. The technological system essentially creates a telephone web or chain by which important information can be shared with all parents and staff members in Barbour County within just six minutes.

Messages can be personalized and sorted to reach everyone or just those on established lists. In cases where the program does not receive a personal or answering machine response, it will automatically make call backs, according to its programming, until the message is successfully transmitted.



Examples of ParentLink's value are reflected in recent county communications regarding such topics as school delays and closures, early dismissals and other urgent announcements. At the school level, principals may tailor messages to their specific parent population on matters such as parent-teacher conferences, report card distribution, immunization clinics, and special event scheduling and cancellations. The system is not designed to be used for fundraising or solicitations.

Barbour County's technology manager, Glenn Sweet, reports that the general response from staff and the community has been positive to date. Any concerns related to misrouted calls can be addressed by contacting him at the BOE office or the individual school principal.
