Belington Students Employ Mock Trial to Study Jurisprudence

On January 19, members of the Belington Middle School eighth grade class completed their study of the American judicial system by traveling to the Barbour County Courthouse to conduct a mock trial. Students were divided into prosecution and defense teams that featured attorneys, witnesses, a defendant and even a bailiff. The students had spent several evenings after school preparing their cases with their teacher-advisors, LaDonna Davis and Sarah Harris.

The groups also received professional advice and information from local attorney, Lisa Weese-Ferguson; Deputy Phil Ferguson; and Magistrate Kathi McBee, who served as judge during the proceedings. The case concluded when the defendant, "Elijah Heater," was found not guilty of arson charges by a jury of twelve BMS peers. Following the mock trial, the group, along with Mrs. Davis, Mrs. Harris and principal, Moke Post, enjoyed lunch at Smokey Ray's restaurant before returning to school.

Back As It Should Be: The PB Roof Is Blue Again!

As of February 1st, all of the metal roofing panels at the “new” Philip Barbour High School were in place, as the primary phase of the repair and replacement project continued during wintry weather. Many panels were damaged during high winds in early 2009, and the decision was made to replace and secure all panels on the structure. Flashing and detail work are now nearing completion, along with the final seaming of the signature blue panels.

The project complements the new roofs installed at the Career and Technical Education Center and the “old gymnasium” wing at PBHS during the fall. Barbour County can now lay claim to some of the newest and most secure secondary school roofing in the state of West Virginia.

Recertification Programs Available to Teachers through Pierpont College

Pierpont Community and Technical College, in partnership with Ed2Go, has announced the availability of several online programs designed to meet Teacher Professional Development recertification requirements. The WV Department of Education has approved these classes for meeting Options 2 and/or 4 on Teacher Recertification Form 4.

While these courses do not count towards degree completion, they are designed for salary increment and recertification upgrades.



Classes start every month, running for six weeks and covering twelve lessons, which can be taken online at the enrollee’s convenience. Update Provided for Junior Elementary School Renovation Project

As the necessary red tape is slowly unraveled, the improvements and renovations to Junior Elementary School will soon become visible and tangible. The \$1.3 million project will involve five components: a new and more secure entrance area to the school; two new classrooms to house programming for the growing PK population in southern Barbour County and realignment of some existing classes; remodeled, centrally-located small group instruction areas; a natural outdoor learning center created by the new construction; and new roofing and HVAC units for the entire structure.



A total of ten general contractors and twelve additional firms representing sub-contractors and

suppliers participated in the pre-bid meeting on February 2nd. The project's clerk of the works, Glenn Sweet, anticipates that bid packages will be received by the middle of the month, with plans in place for a formal recommendation to the Board of Education at its February 22nd meeting.

Another E-Learning Opportunity for Teachers...at Little or No Cost!

West Virginia E-Learning for Educators courses are now available to teaching personnel for non-degree college credit, as arranged through West Virginia University and Marshall University. There is no charge for professional development courses, while the costs for three hours of non-degree graduate credit ranges from \$105 to \$130 depending upon the course.

Registration is open as of February 1st for courses that run from March 3 through April 20, 2010. Related grades will be issued and reflected on transcripts in May of 2010. Graduate class registration forms and instructions are available upon the opening day of each workshop. Participants are responsible for completing the registration process for their specific college program.

February 15th ISE Day Schedule Announced



Barbour County school personnel are asked to take note of the following schedule for ISE day activities planned for Monday, February 15, 2010:

Custodians: Custodians will report to the CTEC (Room 2) from 8:00-11:00 a.m. for staff development. The remainder of their 7.5 hour days will be at their regular work sites.

Cooks: Cooks will work their regular shifts, but will report to the CTEC for a meeting at 11:00 with Rebecca Nesbitt.

Bus Operators/Mechanics: Bus operators will report to the bus garage. Mechanics will attend a meeting at the central office from 11:00 a.m. until noon.

Aides: Instructional aides will start at their regular times. Aides will report to the high school auditorium for the afternoon. See the schedule for teachers below.

Secretaries: Regular work day. Any secretary with a contract of 215 days or more will attend a meeting at the central office from 11:00 a.m. until noon.

Maintenance: Regular work day. All maintenance personnel will attend a meeting at the central office from 11:00 a.m. until noon.

Professional Staff: All professional personnel will follow the normal ISE day schedule during the morning. All professional staff will report to PBHS for sessions during the afternoon from 1:30 to 4:00 p.m.. See the special notes below:



*Elementary, middle and high school teachers of math, science, art, and CTEC staff will report to the auditorium for a session regarding the math initiative. Principals and aides will also attend this session.

*Middle and high school teachers of PE, social studies, language arts, and foreign languages will report to the PBHS media center. This session will build upon the participants' knowledge of the reading initiative.

*Art teachers/elementary art contacts and music teachers will meet at the high school from 8:30 to 9:45 a.m. to plan for the 2010 County Art Show and All-County Music Concert respectively. Those teachers who do not have students to tutor should attend. The meetings will take place in the art and music rooms at PBHS..
