#### PBHS to Host County Math Field Day on February 17th; Open to All Barbour Pupils



The 2014 edition of the annual Math Field Day for Barbour County Schools will take place at Philip Barbour High School during the evening of Monday, February 17. Participating students in grades 4-12 will arrive at PBHS at 4:00 p.m. for registration, with competition at the various levels to follow. Volunteers are asked to be at the site by 3:30 p.m. Parents and school personnel are cordially invited to attend the awards program in the school auditorium beginning at 7:00 p.m. All students will receive certificates of participation, and the winning mathematicians will become eligible to compete in the RESA 7 completion, scheduled for March 29.

#### Traditional Programs Ready to Go During February and March

In addition to the Math Field Day event, other traditional county academic programs have been scheduled for late-winter and spring. Only the county Art Show, usually hosted in May at Alderson Broaddus University, is awaiting final word on a date and time.



The 2014 Golden Horseshoe exam for 8th grade students will begin with the essay portion on February 12, with the multiple choice tests set for March 12 at Belington, Kasson and Philippi Middle Schools.

The annual Young Writers Celebration will take place on March 18 at Philip Barbour High School. Refreshments will be served at 6:00 p.m. with student awards to follow in the auditorium at 6:30.





The evening of March 28 has been set aside for the 2014 All-County Music Concert. The popular hour-long event will get underway at 7:00 p.m. at the PBHS gymnasium. Choral and band rehearsals will take place earlier during the school day.

Certification Reminders: If your teaching certification is due to expire on June 30, 2014, the coursework required for renewal and an application for renewal must be submitted to the Personnel Office prior to the opening of the 2014-15 school term. There have been recent changes regarding certification permits and authorizations recently, and staff are encouraged to contact their colleges with any questions. Also, if you have completed hours that make you eligible for advanced salary classification, it is important to submit all paperwork as soon as the class is completed. The county's state aid funding is based in part on current salary information. More importantly, the state will backdate salary increases only up to three months.

WESTEST Practice Assessments: School administrators and instructional personnel will provide computer-based practice testing for the WEST-EST 2 battery between March 3 and the spring break. These assessments, designed to acquaint pupils with the new format, will include a sampling of released practice items in each of the four core curricular areas. In addition to gauging the readiness of the technology infrastructures within respective schools, the tests will help to familiarize students with computer-based testing procedures and tools such as the online calculator and highlighter.

Site Readiness Test Rescheduled: The date of Tuesday, February 25, has been established as the new date for Barbour County's Site Readiness Test for the Spring 2014 administration of WESTEST 2. The 1:00 p.m. technology "dry run" will help school administrators, building coordinators and technology specialists discover and address any problems within the system prior to the actual testing in May. In the case of school closures or other unforeseen circumstances, a backup date of March 10, 1:00 p.m., has been set.

#### On-line Writing Assessment Portion of 2014 WESTEST Slated for Upcoming Weeks

County principals, along with building level coordinators and technology specialists

completed training for the 2014 On-line Writing Assessment in January and early February 1. The writing assessment, which is an official component of the an-

nual WESTEST 2 battery, will be conducted according to the following schedule windows as established by the WV Department of Education for Barbour County Schools:

#### Kindergarten & PK Registration Set for February 7th at PBHS

Barbour County Schools will conduct student enrollment for the 2014-15 Kindergarten and Pre-Kindergarten programs on Friday, February 7, from 9:00 a.m. to 2:00 p.m. in the auxiliary gymnasium at Philip Barbour High School. Children who are currently attending a PK program will not need to register. Parents are reminded that, by state code, children must attend a state-approved Kindergarten program prior to entering first grade.

Children who will be five (5) years old before September 1, 2014 are eligible for enrollment in kindergarten for the 2014-2015 school year. All county four-year olds are also eligible for PK enrollment during the same session. Barbour County Schools participates in a collaborative pre-kindergarten program (WV Policy 2525).
