### Area Timber Company Partners with Mt. Vernon School and Its Students

The Coastal Timberlands Company, with a local office in Buckhannon, recently purchased tablets for the majority of students at Mt. Vernon Elementary School to use with a WVNET service



called URcast, which allows the children to download teacher content onto their tablets. The hardware and service allows students to use the devices as a flipped classroom at home, on the bus, at basketball games or anywhere else without the need for an Internet connection. The school hopes to provide tablets to all of its students in the near future.



The teaching staff can now use a new server at the school, thanks to the efforts of TIS, Tom Williams, to download learning resources such as videos, books and tests to the individual tablets. Students bring their tablets to school once each week to download the teacher's content. The process is user-friendly, as students simply turn on the devices, which automatically download material onto the student message center. Teachers' learning resources are also stored on their laptops at school for classroom use, saving significant Internet access time, allowing them to devote more time to learning. Because of the new system, the staff reports that both students and teachers are changing the way they think about the processes of teaching and learning.

# **"Friends of George Byrer Field" Host Community Event at PBHS**



On the evening of January 29, The Friends of George Byrer Field hosted several dozen local citizens at the Philip Barbour media center in a twohour program designed to inform the public about the goals of the organization and to solicit their input on how to make the current project as beneficial to the community as possible. FOGBF is a grass roots group that has been dedicated for more than 15 months to providing the children and residents of Barbour County with a first class outdoor athletic, performance and all-purpose facility on the grounds of Philip Barbour High School.

Welcoming remarks by PBHS principal, Mark Lamb, were followed by presentations by FOGBF co-chairs, Mike Cvechko and Brian Bibey, and committee member, Doug Schiefelbein. Philip Barbour alumnus, Lauren Schiefelbein, then shared health and wellness data about the county and West Virginia, linking potential January resolutions of "cutting out and cutting back on" some unhealthy products to funding for the project. Those assembled then divided into six small groups (picture above) to discuss how various fictional personas might benefit from the new facilities and how the complex could be used creatively beyond athletic and performance events. Each group then shared ideas and insights gained during their discussions. The evening ended with door prizes, a light meal and free admission to the PB basketball game.

### Career Center Receives PLTW Funding from Thrasher Engineering Group

During January, Thrasher Engineering of Bridgeport decided to donate funding to a local Project Lead the Way school and selected Philip Barbour High School and its Career and Technical Education Center. As an existing PLTW program, the staff can utilize the \$500 donation to reduce school costs for a number of eligible items. These include: PTLW participation fees, Core Training expenses, program

equipment and supplies, a 3D printer as listed in the purchasing manual, a lab printer, a teacher laptop, or a digital projector and screen. The school will not have any reporting requirements and it will simply be considered a gift restricted to PTLW expenses.

Certification Reminders: If your teaching certification is due to expire on June 30, 2015, the coursework required for renewal and an application for renewal must be submitted to the Personnel Office prior to the opening of the 2015-16 school term. There have been recent changes regarding certification permits and authorizations recently, and staff are encouraged to contact their colleges with any questions. Also, if you have completed hours that make you eligible for advanced salary classification, it is important to submit all paperwork as soon as the class is completed. The county's state aid funding is based in part on current salary information. More importantly, the state will backdate salary increases only up to three months.
