Greetings Everyone,

We have officially recovered from what I hope is the last snow storm we will face this year. I was very impressed with the work of our maintenance crew, custodial staff, transportation department, administrators and everyone else who came out and helped to dig our schools out and get them ready for classes to resume, especially after Winter Storm Jonas.

We are well into the second half of our school year and we have to make sure that we are pushing ourselves to do the best that we can for our students. My late former coach, Joe Paterno, always said, "Every day you either get better or worse, you never stay the same." I believe that is true for all of us in life.

Due to the financial constraints of our school district and a reduction in enrollment (over 100 students less this year than last) I had the difficult task of recommending a reduction of over ten teaching positions and seven service positions to the Board of Education. It is truly the most gut wrenching thing I have ever had to do in my professional life. It is compounded, as far as I'm concerned, because the moves have to be made not based on the quality of the employee, but rather on seniority. The recommendations that were made must be approved by the Board of Education before they can be enacted, and I trust the Board to do what they believe to be in the best interests of the students and staff of Barbour County Schools.

I have asked the Board to run an excess levy this May that is geared toward increasing security in our schools, increasing the technology available to our students and staff, making the funds necessary to build a new bus garage and provide needed maintenance for our schools, and providing our faculty and staff with the resources needed to purchase tools for use in our classrooms. I will be providing everyone with a copy of the official ballot that will be voted on by Barbour County voters on May 10th. I know that, historically, Barbour County residents have been unwilling to pass an excess levy, but when you look at what we want to do to with the funds, I am cautiously optimistic that the voters will step up and invest in our students.

Thank you for all of your efforts to make Barbour County Schools a district that we can all be proud of and for the work that you do for our students on a daily basis.

Barbour County Schools Awarded \$4.6 Million by WV School Building Authority for Local HVAC Improvement Projects

On December 14, Barbour County Schools was named as one of 15 state recipients of Need Grants t by the West Virginia School Building Authority c The competitive process annually results in awards to school systems that submit proposals for capital t improvement projects and follows an evaluation and review process. The total award of \$4,593,322 to Barbour County was the fifth largest in the state for 2015-16.



The local Needs project focuses almost exclusively on energy management upgrades and controls that will result in not only substantial savings to the school system and local taxpayers over the coming decades, but in the creation of positive physical atmospheres that are more conducive to learning for the children of Barbour County.

For example, heating, ventilation and air conditioning (HVAC) units are among the primary components of the project. A majority of these systems in the LEA have reached or exceeded their expected useful life spans. Barbour County Schools proposes significant HVAC renovations to the seven (7) district schools that serve its largest student populations. Other aspects of the project include: lighting upgrades, integration of HVAC components, modern meters for utilities, water conservation measures, ventilation control improvements, and exterior reflective window film installations. A local funding match of \$2,359,200 will take the form of projected energy savings and will not cost the county any precious dollars from its statebasic budget. The total cost of the ambitious project therefore is estimated to be \$6,952,522.

Implementation of the project measures will, in summary, allow the county to: a) significantly improve learning environments for its students; b) bring its buildings into compliance with current ASHRAE and industry standards; and c) extend the useful lives of its school facilities. The upgrades will produce a 21st century system that will provide dependable, economical service for several decades to come.

County Students Earn State Recognition for Perfect Attendance through First 100 Days

In August, State Superintendent, Dr. Michael Martirano, introduced a statewide initiative to improve student attendance rates across West Virginia. Entitled, *Attendance Matters*, the program recognizes that attendance is critical to student success and that too many West Virginia students miss too many days of school. It promotes strategies that support the conclusion that they must be present and engaged to take advantage of the learning opportunities at school to succeed in life.

As part of the campaign, the WVDE has recognized pupils across the state who have achieved 100% attendance for the first 100 days of the school year. A total of 112 Barbour County students (4.6%) have qualified for the honor according to Attendance Director, Glenn Sweet. Three schools surpassed topped seven percent, led by Belington Middle with 7.6%, followed closely by Belington Elementary at 7.5% and Kasson School at 7.2%.

Certification Reminders: If your teaching certification is due to expire on June 30, 2016, the coursework required for renewal and an application for renewal must be submitted to the Personnel Office prior to the opening of the 2016-17 school term. There have been recent changes regarding certification permits and authorizations recently, and staff are encouraged to contact their colleges with any questions. Also, if you have completed hours that make you eligible for advanced salary classification, it is important to submit all paperwork as soon as the class is completed. The county's state aid funding is based in part on current salary information. More importantly, the state will backdate salary increases only up to three months.

Golden Horseshoe Time: Eighth grade students at Belington, Kasson and Philippi Middle Schools will soon vie for the honors of representing Barbour County as Knights and Ladies of the Golden Horseshoe by participating in the annual countywide competition. Coordinated through West Virginia social studies classes, pupils will complete the essay portion of the contest on February 10, with the multiple choice test conducted on February 23.
