Retirement Bonus Guidelines for 2019 Are Announced

This is a reminder that the date for *classroom teachers* to submit early written notification of their intent to retire in order to receive the \$500 bonus authorized by WVC 18A-2-2(g) is now MARCH 1.

In accordance with WVC 18A-2-5a, please note that county boards have the authority to pay, strictly from local funds, up to a \$500 bonus to professional personnel other than classroom teachers or service personnel who provide written notification of their intent to retire at the end of the school year by MARCH 1.

The term "classroom teacher" is defined in West Virginia Code 18A-1-1 as those professional educators who have a direct instructional or counseling relationship with pupils, spending the majority of their time in this capacity. This has been interpreted by superintendent interpretations of 1996 and 2006 to mean teachers in elementary and secondary programs (pre-kindergarten through 12th grade), including speech language pathologists, remedial specialists, counselors, and librarians.

"At the conclusion of the school year" has been interpreted to mean that the classroom teacher must complete his/her employment term for the current school year and not work the first day of the employment term of the following school year. Consequently, classroom teachers are eligible for the bonus if they retire anytime during the summer break, as long as it is before the first employment day of the subsequent school year. They are NOT eligible for the bonus if they must work any days as a regular employee during the subsequent school year to become eligible for retirement.

"Written notification" has been interpreted to mean that the teacher has submitted a written request to retire from employment with the school board at the end of the current school year, and the board has taken board action to accept or approve the request. Upon acceptance by the county board, the classroom teacher becomes eligible for the bonus.

Regarding "bonus amount," the \$500 bonus is for the classroom teachers who are employed full time in their positions. If a teacher is employed less than full-time, the bonus will be computed on a full-time equivalence (FTE) basis; for example, teachers employed half-time will receive a bonus of \$250.

Also, since WVC 18A-2-2(g) explicitly states that classroom teachers are to be paid \$500 for providing early notification and WVC 18A-2-5a explicitly states that county boards may pay \$500 or less to any professional employee who is not a classroom teacher or to any service personnel, it is the Department's opinion that county boards do not have the authority to increase the bonus above the amounts stated.

Legislative Changes Are Enacted for Cooperating Teachers

Faculty members who are considering the supervision of student teachers should note some related policy requirements that were enacted during the last legislative session:

- 1. If you took the mentor training in the past offered through the CPD you are qualified to take student teachers without any additional certifications or training.
- 2. If you haven't completed mentor teacher training, the information below describes an online opportunity through the WVDE. This module does not qualify you to be a mentor teacher for beginning teachers. It only satisfies the requirement to supervise student teachers.
- 3. If you have NBPTS certification you do not need either training.



"World in 3D" Grant Helps Spur STEM Learning at Kasson School

Students and staff members at Kasson Elementary/ Middle School will soon be taking a further step into 21st century STEM learning when the school's new 3D printer becomes fully operational. The new technology was acquired through a successful *Families*

Leading Change minigrant of \$2000 awarded during December.

Members and parents of the school's robotics team saw such a printer in action during a recent competition and urged



their coaches to look into the possibilities of securing one for KEMS. The new printer, filament and build sheets will be supplemented in the future through support by the school and its PTO.

One of the biggest project benefits will be the ability of robotics students to produce replacement parts for the robots right on campus instead of spending precious dollars to purchase them. Younger students will enjoy printing their own 3D Christmas ornaments and other curriculum-related items. Mentoring and instruction in coding, slicing and the operation of the technology will be key ingredients in making 3D printing an integral part of STEM learning at Kasson.


