PARA 1104 Pierpont Community and Technical College

This course will focus on the application of good communication skills to conduct client, witness, and expert interviews; the development of factual analysis and research skills to plan and execute an effective investigation; and the rules of ethics and evidence as they relate to interviewing and investigating.
