Minutes

The Barbour County Board of Education met in special session at 5:30 p.m. on Tuesday, April 18, 2017 at the Board of Education Office, 45 School Street, Philippi, WV 26416.

Ron Phillips, Adam Starks, Eric, Ruf, Joanne McConnell, Members, and Jeffrey Woofert, Secretary, were present. David Everson, Member, was absent. Also in attendance were: Jeff Kittle, David Neff, John Roush, Sherman Wilkinson, April Paugh, Vernon Woods, Valarie Cross and William Cather.

Mr. Ruf called the meeting to order at 5:30 p.m.

A personnel hearing was conducted in open session for April Paugh.
