

BARBOUR COUNTY SCHOOLS NOTIFICATION PROCEDURES FOR

HOME INSTRUCTION

(REVISED 2024)

In accordance with West Virginia Code 18-8-1, Exemption (c), the following information shall be provided to Barbour County Schools prior to Home Instruction taking place.

- 1. Homeschool parents will provide to the county superintendent a one-time Notice of Intent (NOI) to homeschool. The notice, for any child of compulsory school age to be instructed, must contain:
 - a. Name of child, address, age of child, birth date
 - **b.** Assurance that the child shall receive instruction in reading, language, mathematics, science and social studies and that the child shall be assessed annually.

(Provided, that if a child is enrolled in a public school, notice of intent to provide home instruction shall be given at least two weeks prior to withdrawing such child from public school.) and (preferably using the recommended county notification of intent form).

- 2. The NOI will remain in effect until the parent notifies the county superintendent upon termination of home instruction for a child who is of compulsory school attendance age, enrolls for public education, OR upon establishing residence in a new county. At such time the parent shall notify the previous county superintendent and submit a new NOI to the superintendent of the new county of residence.
- 3. In addition to the NOI, the parent must provide evidence of the proper education credential. If that credential is already on file with the county, it is not necessary to provide that information again.
- 4. Home school parents must obtain an annual assessment for your child/children and you must maintain a record of that assessment for three years. This shall be satisfied in one of the following ways:
 - **a.** Nationally normed standardized testing (Results due to the superintendent of schools on or before June 30 of the year being assessed).
 - **b.** Participates in the testing program in use in the state's public schools.
 - c. A written narrative indicating that a portfolio of samples of the child's work has been reviewed and that the child's academic progress for the year is in accordance with the child's abilities. This narrative shall be prepared by a certified teacher or other person mutually agreed upon by the parent and county superintendent. It shall be submitted on or before June 30 of the school year being assessed.
 - **d.** An alternative academic assessment that is mutually agreed upon by the parents and the county superintendent.
- 5. Results of the required academic assessment must be submitted to the county superintendent for any child in grades 3, 5, 8, or 11. Those results must be submitted by June 30 of the year in which the assessment was administered.

All requests/notifications to provide home instruction are reviewed by the Barbour County Superintendent of Schools. Barbour County Schools, once the home instruction notification has been verified as to meeting the requirements of the law, will assist you in obtaining student textbooks if requested in writing. Teaching materials and other resources will be available upon request and subject to their availability as defined in West Virginia Code. **Please note: Credit toward graduation from a public high school cannot be earned through home instruction. Barbour County Schools does not accept home school work or credits from schools not accredited
