



**ROUTES TO PHILIPPI:**

**From Charleston, WV**

Take I-79 N. to exit 115, S. on Rt. 20, E. on Rt. 57, and N. on 119.

**From Pittsburgh, PA/Morgantown, WV**

Take I-79 S. to exit 115, S. on Rt. 20, E. on Rt. 57, and N. on 119.

**From Elkins, WV**

Take Rt. 250 N. to Philippi.

**From Ohio**

Take I-77 south to Parkersburg and Rt. 50 east to I-79 at Clarksburg and I-79 S to Exit 115; or I-70 east to I-79, south to Exit 115 at Clarksburg; then Rts. 20 south, 57 east, and 119 north to Philippi. (22 miles from Exit 115).

**WALK**

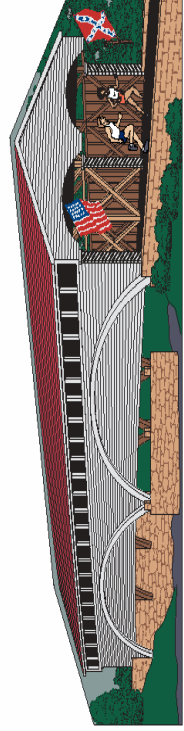
20 & under, 21-30, 31-40, 41-50, 51-60, 61-70, and over 70

### **Blue and Gray 5K Race Course**

Start on Walnut Street right down from the Court House on the Start line. Go on Walnut Street across the Iron Bridge and then turn right on Beech Ave. Shortly after you turn, you will veer right on Sycamore Street. Go down Sycamore Street until you can turn right back on Beech Street. Turn right on Birch Avenue. Turn right at Birch Avenue and Fifth Street onto Maple Avenue. Go down Maple Ave. to the turn around. Come back on Maple Ave. and go to Route 119. Turn left at the stoplight. Turn left and go through the Covered Bridge to the light. Go on Pike Street back onto Walnut Street. Finish line is behind the Court House.
